

JUDICIAL TORMENT WITHOUT REMEDY

I am sending you this correspondence as a feeble yet desperate attempt in trying to gain help with attention to some issues. With eager emotional longing I view the occasional story of victims getting justice when a certain media investigates into their story of trauma. With sorrowful envy, I wonder if I could ever stand the chance of experiencing a triumphant ending. Must I die without ever getting any of the judicial conspiracies investigated, with the publicity of the media? Why does the media pursue publicizing the errors of a corporation toward a victim, but when it involves to a judge or the judicial structure, why can't I get a response from anybody?

Why can a judge have a 2nd DUI and never serve jail time? Why can she hide her violation in a site where it required a special access code? Why did the DUI offense NOT come up in the regular list of offenders of the same crime? Is it illegal for a courthouse to sign an agreement that all the judges will rotate assignments every two years, but then remain in their same assignment for at least a decade? Is it illegal for a judge to make rude and threatening comments? Is it OK for the judge to say to a teenager in her courtroom, "I should step out from behind this desk, come down and kick your teeth down your throat!"? Was there any violation when she did come down on the court floor in front of a different teenager, ridiculing him with words and gestures? If not illegal or traumatic for the child, why would the teenager go home and commit suicide? I heard he hung himself!

Why can a judge refuse to look at the facts, and place a decision on her own whim of ideas? Why can she slander someone in the courtroom, then sentence them to six months of jail, based on her lies? I have proof of her slander in my transcripts! Once in jail, I had a friend of mine start up a website for me- www.screwedkenoshastyle.com . Once it was live, was it legal for her to release me after only serving three months? During the next two months I continued with the website and requested a hearing to correct the mistakes. Was it legal for her to run out of the courtroom as I entered it? Was it legal for her to simply arrest me to finish my six months without giving me the hearing that was established? Was it legal for her to alter transcripts by deleting comments that she said within the courtroom?

I wrote a book on the experiences of what it was like within a cult, "**TORN ASUNDER, In The Jaws Of A Cult**" which is published by authorhouse.com. In that book I elaborated on the child abuse and death that happens within that group. Was it legal for her to completely refuse the danger that the children in that group must endure, and sometimes die in? Read the book of the gruesome details.

If the judges are not doing an illegal act, why have five judges recuse-d themselves off of my case? Why did the one Judge M. sit on his first hearing with my case, stutter and quickly reschedule the hearing for three months later? Why did he recuse himself then the next month? My case was transfered to the next judge. Was it legal for Judge S. to ignore the scheduled hearing? Was it legal for the court to never notify that Judge M. did recuse himself and that there was no hearing? Was it legal for Judge S. to violate the statute that demands transcripts to be made? Was it legal for him to order the reporter NOT to take notes for the entire hearing? Was it legal for him then to elaborate that he has NO problem with "**beating children with sawed-off golf clubs!**"? Why can't the over half a dozen people in that private hearing, be placed on a lie detector to verify that he said those things? If it was not illegal, why did he throw me in jail when I placed that information on my website? Why did he also recuse himself after that?
